## THE THEME OF TIME

Tempora mutantur, et nos mutamur et illis. "The times change, and we change with them". No I am not a latin scholar, but I did work in the Supreme Court in Canberra for four years, and then in the Magistrates' Court in Wellington for three years. I possess a booklet, foolscap size and thirty seven pages long of the regular latin phrases used by solicitors and barristers in the Supreme Court (of Australia) in Canberra. My job was as a sound recording reporter, and the main task was to sit at a recording console and listen on a headset (in the courtroom) to the whole of the proceedings from start to finish. The typists in the commonwealth reporting service had to transcribe from recording from a landline the exact same process I was monitoring. Those learned men standing at the bar table addressing the presiding judge frequently used latin phrases and this booklet was "our dictionary" because we had to interpret them correctly. If you come across one in your research give me a call and I will look it up. You might ask what this has to do with family history? For starters there is a potted history of part of my working life. Secondly it is important when looking at your family history documentation and you come across a legal document, and you are suddenly stalled because there is that latin phrase. Just give me call.

We had a very attentive group watching Robert Barnes try to guide us through FamNet, but I think many of us are still wondering! # Irish registers will be online from 8th July

According to <u>Irish Genealogy News</u>, the excellent blog written by LostCousins member Claire Santry, Wednesday 8th July has been named as the day when 390,000 images of Catholic parish registers from 1,091 parishes across Ireland will be made available online - and they'll be free!

# FAMILY HISTORY NOTEBOOK

Here at Waikanae we have developed a more user friendly A4 size family history notebook, it is in ring binder form and has the flexibility of being a ring binder, only 16mm across the spine. It contains notes on usage, on note taking; it has ruled paper for note taking and plastic pockets all of which are removable, or the number can easily be increased. More importantly it has blank family group sheets, a large fold out A3 size pedigree chart It also contains Census and Electoral Roll check lists. There is also a copy of the Chapman Codes for your reference.

There are at least two "commercially made" A5 size booklets on the market which look good but both are badly designed especially in the area of space available for example, if a person has three given names, the space available is barely enough for two. Some members of our group are using "The Waikanae Family History Notebook" – at a giveaway price of just \$10 – if you are a brand new member we may even discount that price. <u>On sale or to view (or haggle over the price) at the next meeting.</u>
